1. Product Overview

The purpose of this Pricing Guide is to provide documentation with regards to pricing Sprint International Taiwan ("Sprint Taiwan") End to End International Private Line (IPL) service between Taiwan and selected countries around the world.

Sprint Taiwan End to End IPL service provides for two-way simultaneous transmission of digital signals at speeds ranging from 64 Kbps up to 155 Mbps (STM1). Dedicated, non-switched circuits connecting two customer locations provide exclusive transport capacity for a customer's voice, data, and / or video traffic. Circuits are dedicated to the customer and are not shared among multiple users. Sprint Taiwan End to End IPL service is provided at fixed monthly rates and is available for the customer's use 24 hours per day, 7 days per week.

2. End to End IPL services

Sprint Taiwan offers the following End to End IPL services:

2.1 End to End IPL Fractional 1.5

Sprint Taiwan End to End Fractional 1.5 service is a digital transmission service providing digital signals at speeds ranging from 64 Kbps to 1.5 Mbps.

2.2 End to End IPL 2.0

Sprint Taiwan End to End IPL 2.0 service is a digital transmission service providing digital signals at the speed of 2.048 Mbps (E-1). E-1 service carries up to 30 DSOs (64-kbps equivalents) of useable bandwidth. ¹

2.3 Higher speed End to End IPL Service

Sprint Taiwan also offers End to End IPL service at speeds greater than 2 Mbps. Pricing for higher speed service is not included here but is available by request.

NOTE: The obligation of Sprint Taiwan to provide service is dependent upon its ability to procure, construct, and maintain facilities which are required to meet the customer's order for service. Availability of IPL service must be confirmed at the time the order is placed.

3. Pricing

3.1 **Pricing Components**

Pricing for End to End IPL service consists of three components:

- a) Taiwan originating access;
- b) International facilities;
- c) Access in the terminating country.

¹ The DSO equivalents are for capacity illustration only. This does not imply that Sprint Taiwan provides channelized service at these bandwidths.

Pricing for Taiwan originating access is determined in conjunction with the local access provider. To provide connectivity from Sprint Taiwan's node to the customer premises, Taiwan local access will be provided by a licensed local access carrier.

Sprint Taiwan arranges with the local access provider for local access on behalf of the customer.

NOTE: Customers have the option of obtaining local access on their own. It is not required that they go through Sprint Taiwan for this service.

Pricing for the international facilities is provided here. Pricing for terminating access will vary by location and is available upon request.

NOTE: In the event of a rate change now or in the future, the customer will be charged the rate agreed to in the customer contract.

3.3 <u>Terminating Regions of the United States</u>

Pricing from Taiwan to the United States or U.S. territories varies by U.S. terminating region. The four terminating regions of the United States are as follows:

<u>U.S. West</u>: Arizona, California, Colorado, Idaho, Montana, Nevada, New Mexico, Oregon, Utah, Washington, and Wyoming, Hawaii, and Guam.

<u>U.S. Central</u>: Alabama, Arkansas, Illinois, Iowa, Kansas, Kentucky, Louisiana, Minnesota, Mississippi, Missouri, Nebraska, North Dakota, Oklahoma, South Dakota, Texas, Tennessee, and Wisconsin.

<u>U.S. East</u>: Connecticut, Delaware, District of Colombia, Florida, Georgia, Indiana, Maine, Massachusetts, Maryland, Michigan, New Hampshire, New Jersey, New York, North Carolina, Ohio, Pennsylvania, Rhode Island, South Carolina, Vermont, Virginia, West Virginia, U.S. Virgin Islands and Puerto Rico.

Alaska: Individual case basis.
