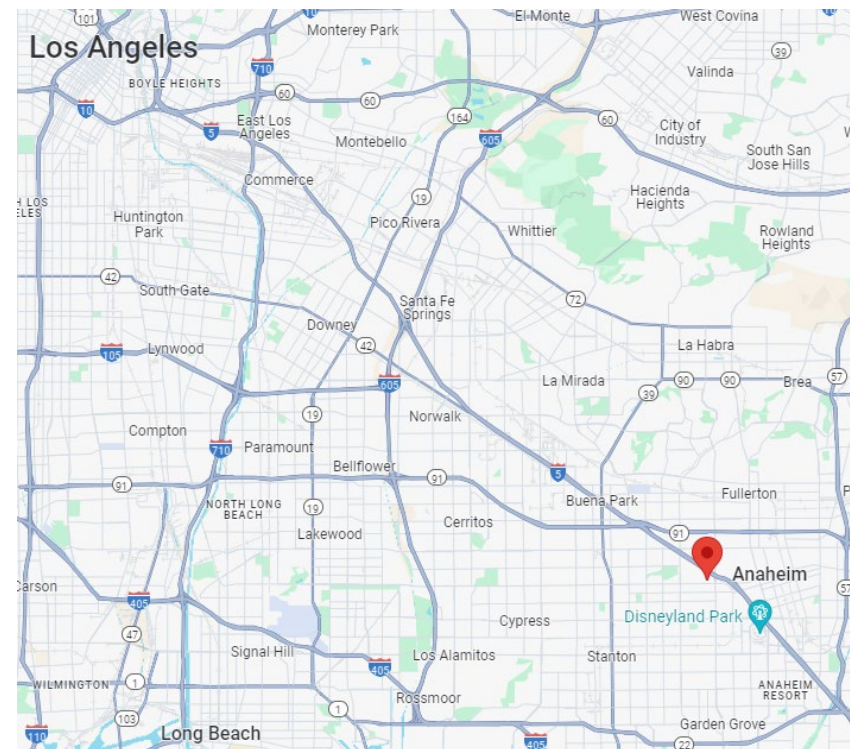


General Information

Conveniently located outside Los Angeles, near downtown Anaheim, Cogent's Anaheim data center is a 55,240 sq ft secure facility with 4.00 MW of power. Facility sits on 2.5 acres zoned for Industrial Use, allowing for potential expansion. Additional power availability being verified with utility provider, Anaheim Public Utilities.

Offering 3.42 MW of protected power and 31,900 sq ft of wholesale colocation space, this data center is ideally situated to serve customers in the Anaheim area and throughout the Southwestern region.

As a carrier neutral facility, available carriers include Cogent, Verizon, Time Warner, TCG, MFS (Verizon Business), Level-3/Century-Link, ICG, and AT&T with the ability to bring in additional carriers and dark fiber providers as required.

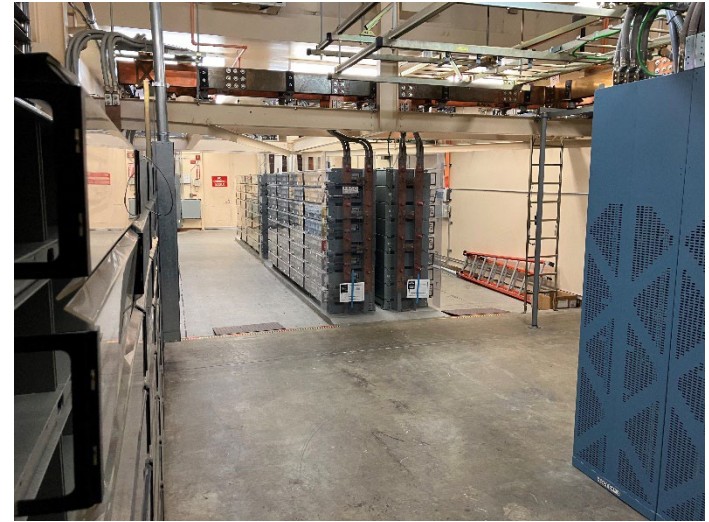

- Each standby generator has individual diesel fuel system, including sub base fuel tanks, separate fuels tanks with day tanks & fuel monitoring systems.
